



10 YEARS LIMITED WARRANTY CERTIFICATE



SOLID CLEAR POLYCARBONATE SHEET

This guarantee covers yellowness and light transmission of UV protected POLICAM solid polycarbonate sheets.

Guarantee Statements:

- 1- Policam solid polycarbonate sheets keep its yellowness as follow; The yellowness index value change after 10 years will be max. 10 Delta units according to ASTM D 1925.
- 2- Policam solid polycarbonate sheets keep its light transmission as follow; The light transmission value change reading after 10 years will not exceed more than 6% according to ASTM D 1003.

Guarantee Conditions:

To be covered by the guarantee POLICAM solid polycarbonate sheets must be;

- 1-Stored, transported, fabricated, handled, maintained and installed correctly,
- 2-Not scratched, abraded, cracked.
- 3-Not exposed to chemicals, adhesives and sealants.
- 4-Not exposed to extremes of temperature for prolonged periods of time.
- 5-UV protected side has to be exposed to direct sun light.
- 6-Sheet should not be exposed to artificial light sources which emits intense UV energy and radiation.

NOTE: If customer requires sheet without UV protection layer or less than standard UV layer thickness, the limited warranty is not valid.

10 YEARS LIMITED WARRANTY

General Conditions: POLICAM SOLID CLEAR POLYCARBONATE SHEETS

Guaranteed values are measured from flat specimens with parallel faced cut out material, and sheet surface has to be cleaned before measurement.

The guarantee refers to sheets which are not thermoformed, bended and without surface treatment.

Guarantee Period:

The limited guarantee starts from the date of customer receives the sheets and ends after 10 years time.

Applicability:

If the claim is justified under this warranty the replacement will be as follow. The sheets will be collected by the customer with ex-works Işık Plastik factory terms.

Up to 3 years	100%
Within 5th year	75%
Within 6th year	50%
Within 7th year	40%
Within 8th year	30%
Within 9th year	20%
Within 10th years	10%

In the event of a claim against this warranty, the sheet and the original sales receipt must be returned to IŞIK PLASTİK via the sales representative.

Işık Plastik has the right to investigate independently the cause of any failure. Işık Plastik has the right to examine the complaint on site.

The manufacturer's liability doesn't include any cost of removal and/or installation of sheets. Işık Plastik is not responsible any other damaged or lost of rights whether directly or indirectly.

The complaint will be taken in consideration if the supplier's related invoice and products complete description label presented. The supplier should be informed about the number of faulty sheets. In case of need product sample must be sent to producer.
